1. Bids on appropriate forms are invited from members of the public including traders, dealers, companies, etc, for the sale on an 'AS IS WHERE IS' basis of above mentioned goods.
2. **The goods may be viewed at the MRA-Customs Auction Sales Warehouse, Lux Shed, Mer Rouge as from Wednesday 23<sup>rd</sup> March 2011 to Tuesday 29<sup>th</sup> March 2011 from 10.00 hrs to 15.00 hrs on weekdays and from 09.30 hrs to 11.00 hrs on Saturday 26<sup>th</sup> March 2011.**
3. The list of items can be viewed on the Mauritius Revenue Authority's website: <http://mra.gov.mu> as from Wednesday 23<sup>rd</sup> March 2011.
4. The Bid Form may be downloaded from the Mauritius Revenue Authority's website or collected from the Counter at the ground floor, Custom House, Mer Rouge, Port Louis and also from the MRA-Customs Auction Sales Warehouse at Lux Shed, Mer Rouge as from Wednesday 23 March 2011..
5. Tenders duly filled should be addressed in sealed envelopes marked "Tender Quotation 01 of 2011" and deposited in the Tender Box at the Registry Section, Custom House, Mer Rouge, Port Louis or at the MRA-Customs Auction Sales Warehouse, Lux Shed, Mer Rouge by Tuesday 29<sup>th</sup> March 2011 to 15.00 hrs at latest
6. **Offers should be open and remain valid for acceptance for a period of two months with effect from the closing date, and should be accompanied by bank cheque drawn in favour of Director General, MRA for an amount representing 10 % of the tender offer. Upon acceptance of offer, the bank cheque will be automatically treated as non-refundable and will be realised and enforced immediately.**
7. Offers received after the prescribed date and time shall not be considered.
8. Bidders may bid in any quantity indicating the quoted price per unit.
9. Successful bidders shall effect payment and take delivery of ALL ITEMS AWARDED within 2 weeks as from the date of the letter of award, failing which the offer will lapse. Payment can only be effected either in cash or Office Bank Cheque drawn in favour of Director General MRA.
10. The MRA reserves the right:
  - a. To accept or reject any bid, or
  - b. To split the bid, or
  - c. To annul the bidding process and reject all bids at any time prior to the award of the tender without thereby incurring any liability or any obligation to inform any bidder of the grounds for accepting or rejecting any bid.
11. Bidders are not allowed to bid for the same items more than once.
12. Tenders with erasures or written with lead pencils shall be rejected.
13. VISITORS ARE REQUESTED TO BRING ALONG THEIR IDENTITY CARDS FOR ACCESS AND REGISTRATION PURPOSES AT THE PORT MAIN GATE.
