COMMUNIQUE

FILING OF INCOME TAX RETURN & PAYMENT OF INCOME TAX FREE INCOME TAX ASSISTANCE (FITA) SCHEME 2009

Filing of Return

- 1. As per Income Tax Act, the return of income should be filled in and forwarded so as to reach the office of the Director General, MRA, not later than 30 September 2009 by every person who:
 - (i) has a chargeable income; or
 - (ii) at any time during the income year ended 30 June 2009 was an owner of:
 - (a) any residential property on which the National Residential Property Tax is payable;
 - (b) more than one residence;
 - (c) one or more immoveable property acquired for an aggregate price exceeding Rs 2 million or on which he has incurred expenditure for the construction of a building or any other structure of an aggregate amount exceeding Rs 2 million:
 - (d) a car with an engine capacity exceeding 2000 cc; or
 - (e) a pleasure craft as defined in the Tourism Act 2004.
- 2. Income tax forms have already been sent to taxpayers by post.

- 4. In order to assist taxpayers to fill in their individual Income Tax returns for the year of assessment 2009/2010, the Mauritius Revenue Authority will operate Free Income Tax Assistance (FITA) scheme on Saturday 26th and Sunday 27th September 2009 from 08h30 to 16h30 in the following FITA centres.

- 5. Any person requiring information and assistance may call at any FITA centre nearest to his place of residence and bring with him the original of the Statement of Emoluments and Tax Deduction duly certified and signed by his employer.
- 6. Facilities will be made available at every FITA centre for taxpayers to file their returns **electronically**.

Payment of Income Tax

- 1. Arrangements have been made at the above FITA centres to receive income tax payments either in cash or by cheque on 26th and 27thSeptember 2009 from 09h00 to 16h00.
- 2. Cheque should be drawn in the name of the Director General, MRA and crossed "Account Payee Only", please insert your Tax Account Number (TAN) on the verso of the cheque.
- 3. It is brought to your attention that in case of non-submission of return a penalty of Rs 2000 per month up to a maximum penalty of Rs 20 000 will be applicable. In addition, a penalty of 5% of the amount of tax remaining unpaid together with interest at the rate of 1% per month will accrue.
