## **Annex VI**

## (Referred to in Article 16 of this Agreement)

- 1. Customs duties on imports into Mauritius of goods originating in Turkey, other than those listed in Table A, B, C and D to this Annex shall be abolished upon the entry into force of this Agreement.
- 2. Customs duties on imports into Mauritius of goods originating in Turkey which are specified in Table A shall be abolished as of 1 January 2013, and those specified in Table B and Table C shall be progressively eliminated as hereunder set out.
- 3. The successive customs duty reductions shall be based on basic duty mentioned in column 2 as provided in Table B and Table C below. However, at the time of importation in cases where MFN rate of Mauritius is lower than the basic duty or where the basic duty is lower than the MFN rate of Mauritius the lower duty rate shall apply to the imports of products covered by this Annex from Turkey.
- 4. Customs duties on imports into Mauritius of goods which are listed in Table D shall be excluded from liberalization.
- 5. The agricultural products originating in Mauritius listed in the following Table E shall be imported into Turkey according to the concessions set out below. The agricultural products originating in Mauritius other than those specified in the following Table shall not be subject to any concessions while imported into Turkey.
- 6. The Parties, through the Joint Committee, will ensure that negotiations with a view to offering market access to Mauritius for sugar are started immediately upon the entry into force of this Agreement
