All the mandatory fields on the page will need to be filled in before clicking on the submit button. Care has to be taken that all the "\*" marked fields (mandatory inputs) are input. Email address, National Identity Card number (for Mauritian Citizens) and contact numbers are mandatory inputs. Foreign nationals must insert their Passport Number in the appropriate field.
- The E-Auction sale will start on Wednesday, 22 December 2021 at 09.00 Hrs. and will close on Wednesday, 29 December 2021 at 12.00 Hrs. Items will be displayed for public viewing on Monday 27 December 2021 and Tuesday 28 December 2021 from 10:00 Hrs. to 15:00 Hrs. at Lux Shed, Mer Rouge, Port Louis.
- 4. The time indicated on the MRA Online Auction System will be the system time of Customs and no other time will be taken into account. The time indicated on the MRA Online Auction System will be the correct time for the purpose of auction.
- 5. The sale is on an '<u>AS IS WHERE IS</u>' basis and the pictures posted on the Tender List may not reflect, quantity, weight, size dimensions, specifications and features of the item.
- 6. Offers should be open and remain valid for acceptance for a period of two months with effect from the closing date. All Bids shall be accompanied by a deposit of at least 10% of the tender offer. Deposit should be by way of banker's cheque drawn in favour of Recovered Asset Fund. Deposit will be returned to bidder if not awarded and forfeited if awarded bidder does not make payment and take delivery. Personal cheques will be rejected.

# INVITATION TO BID

- 7. Bids will be considered only if proper information has been correctly filled with respect to Bank name, Cheque Number and Amount of the banker's cheque when submitting the bid on the MRA Online Auction System. Any bids inadequately filled on the MRA Online Auction System will be rejected.
- 8. Offers received after the closing date and time shall not be considered.
- 9. The MRA Online Auction System will not allow bidders to bid for the same item more than once.
- 10. The MRA Online Auction System will not allow bidders to bid for items offered for sale for the first and second time below the reserved price.
- 11. The highest bidder will be normally offered the goods subject to the approval of the Tender Committee set up for that purpose.
- 12. Successful bidders shall effect payment and take delivery of ALL ITEMS AWARDED within 5 days as from the date of the letter of award, failing which the offer will lapse. Payment can only be effected either in cash or Office Bank Cheque drawn in favour of the Recovered Asset Fund. Delivery must be taken within two days after payment on appointment.

  - b. To annul the bidding process and reject all bids at any time prior to the award of the tender without thereby incurring any liability or any obligation to inform any bidder of the grounds for accepting or rejecting any bid.
