ITEM E10 OF PART II TO THE FIRST SCHEDULE TO CUSTOMS TARIFF ACT***E 10 - Any passenger***

(1) Subject to paragraph (3), goods which are not unaccompanied luggage and which:

- (a) have been imported by a passenger who is under the age of 12 years or who is travelling on a non-Mauritian passport; and*
- (b) do not exceed for duty purposes a value of Rs15,000.*

(2) Subject to paragraph (3), goods which are not unaccompanied luggage and which:

- (a) have been imported by a passenger other than a passenger specified in paragraph (1); and*
- (b) do not exceed for duty purposes a value of Rs 30,000.*

(3) For the purposes of paragraphs (1) and (2), "goods" shall exclude arms and ammunitions, tobacco in any form, wines and spirits and merchandise for sale.

ITEM 10 OF PART 1 A OF THE FIRST SCHEDULE TO THE EXCISE ACT***10. Any passenger***

(A) (i) tobacco (including cigars and cigarettes) not exceeding 250 grammes;

- (ii) spirits not exceeding one litre; and*
- (iii) wine, ale or beer not exceeding 2 litres; or*

(B) (i) tobacco (including cigars and cigarettes) not exceeding 250 grammes; and

- (ii) (a) spirits not exceeding 2 litres; or*
- (b) wine, ale or beer not exceeding 4 litres;*

when imported as his accompanying bona fide baggage by a passenger of 18 years of age or over for his personal use and consumption and if declared upon entry.

Provided also that excise duty shall be paid on any quantity purchased in a duty free shop in Mauritius or imported in excess of those amounts respectively.
