DECLARATION/UNDERTAKING BY THE HOLDER OF A MAURITIAN DIASPORA REGISTRATION CERTIFICATE

I, the undersigned,....., hereby declare that I am the holder of a Mauritian Diaspora Registration Certificate, a copy of which is hereby annexed, coming to serve Mauritius and to participate in its economic development. I also declare that I have never claimed or benefitted from excise duty concession as a returning citizen of Mauritius under item 3 of Part IA of the First Schedule to the Excise Act.

I am aware of the fact that:

- (i) I have been exempted from the payment of the excise duty on a motor car under the Excise Act, which as per the Regulations is up to a maximum of 2 million rupees;
- (ii) Any breach to any of the conditions under this exemption shall be dealt with in accordance with the provisions of the Customs laws, the Investment Promotion (Mauritian Diaspora Scheme) Regulations 2015 and the Investment Promotion Act;
- (iii) In case I shall be deregistered under the Scheme, I undertake to comply with the provisions of subsection 9(6) of the Investment Promotion (Mauritian Diaspora Scheme) Regulations 2015.

I hereby undertake, for a period of 4 years, to **forthwith notify** the Director-General, MRA in the event that I intend to sell, transfer, use or apply the motor car, other than in respect of which the concession was granted or in case I am not able to comply with any of the conditions regarding this concession. In this regard, I also undertake to pay duty and taxes as per the provisions of Section 5 of the Customs Tariff Act;

I hereby also declare that all particulars furnished in this application and the documents submitted are true and correct.
