International Customs Day 2018 & Launching of MRA Corporate Plan 2018-2020

Honourable Pravind Kumar Jugnauth, Prime Minister, Minister of Home Affairs, External Communications and National Development Unit, Minister of Finance and Economic Development was the Chief Guest at the Mauritius Revenue Authority (MRA) Custom House for the International Customs Day (ICD) 2018 and the Launching of the MRA Corporate Plan on Friday 26 January, 2018. The Prime Minister was welcomed by Mr. Sudhamo Lal, Director-General of the MRA and Mr. V. Ramburun, Director, Customs, in the presence of members of the MRA Management Team.



The ICD is a yearly event which marks, on one hand, the inaugural session of the-then Customs Cooperation Council (CCC) in Belgium in 1953 and recognises, on the other, the challenging role of customs officials and administrations around the world.

In its Corporate Plan, the MRA lays down its key strategic objectives alongside key projects and initiatives that it intends to implement between 2018 and 2020.

Upon arrival, the Prime Minister visited the Customs K9 Unit, met newly-appointed Customs Officers and launched the newly-acquired MRA Drone. An exhibition of Drug Detecting Equipment was also held inside the Atrium at the Custom House.



The official ceremony began at 17h00 on Level Six. In his keynote address, Honourable Pravind Kumar Jugnauth emphasised that the theme of the ICD 2018 is in harmony with the vision of the Government to become a high-income country. The Prime Minister thanked the staffs of the MRA Customs Department who work round the clock to ensure that our borders are secured and that licit trade is being conducted in a safe and fair environment.

The Prime Minister also congratulated the MRA for launching its Corporate Plan 2018-20 and assured his continuous support to achieve the set goals.

The Director-General of the MRA, Mr. Sudhamo Lal, thanked the Prime Minister for his presence in his speech and highlighted that the MRA Corporate Plan englobes 107 projects and initiatives which are allocated to MRA's 13 Directorates for a time period of 3 years.

In his speech, the Director of the Customs Department of the MRA, enumerated the various initiatives undertaken to combat drug trafficking, namely the setting up of the Customs Anti-Narcotics Section, sniffer dogs, Brigade des Marchandises, extensive use of CCTVs at the ports, inter alia.







Two videos on the new MRA Customs projects (Mobile App, Online Currency Declaration, Motor Vehicle Corridor and MRA Drone) and seizures made by the MRA Customs were broadcast, prior to a presentation by Mr. R. Oree, Ag. Assistant Director, Research, Policy & Planning on the MRA Corporate Plan 2018-20.

Thereafter, Honourable Pravind Kumar Jugnauth was invited to launch the MRA Corporate Plan 2018-2020, the **Customs@MU** and the **MRAeasy** Mobile Apps. Eight WCO Certificates were also awarded to Customs Officers and external stakeholders by the Chief Guest. The official ceremony ended at around 18h00.

Drug Seizure effected by MRA Customs

The Mauritius Revenue Authority (MRA) and the Anti-Drug and Smuggling Unit (ADSU) seized 300g of heroine worth Rs. 4.5 million at the SSR International Airport on Sunday 28 January, 2018. The suspected drugs were concealed in the handles of a suitcase which belonged to a Malagasy passenger.



Officers of the Customs Anti-Narcotics Section (CANS) profiled the 36 year-old male passenger who arrived on board flight MK 289 from Madagascar and his suitcase was scanned. The scanning images showed suspicious matter inside the handles of the suitcase. The handles were dismantled and a brownish powder suspected to be heroine was found stuffed in black plastic inside each handle.


A field test for heroine was carried out and the result was positive. Sniffer Dig Milan reacted positively to the brownish powder. The drugs and the passenger were handed over to ADSU for further investigation. A controlled delivery led to the arrest of two Mauritian citizens.

MRA receives South Korean delegates

The Director-General of the Mauritius Revenue Authority (MRA), Mr. Sudhamo Lal, welcomed three delegates from South Korea Customs Service in the presence of Mr. V. Ramburun, Director, Customs on Monday 29 January, 2018 at the MRA Head Office.



The delegation was made up of Mr. C. Nam, Mr. K. Park and Mr. J. Park, Director and Assistant Directors respectively at the Information Planning Division of the South Korea Customs Service. The mission in Mauritius lasted for three days and the delegation left on Wednesday 31st January, 2018.



MRA collaborates with IJLS

In line with its strategic objective of 'Promoting Tax Compliance', the Mauritius Revenue Authority (MRA) organises regular working sessions with its stakeholder from the private sector. Following changes brought to the Finance Act, the MRA organised a workshop in collaboration with the Institute for Judicial & Legal Studies at the Happy World House on Monday 29 January, 2018.



The aim of the session was to sensitize MRA stakeholders on the implications of the fiscal changes to promote compliance and the MRA resource persons were Mr. D. Seetloo, Section Head, Large Taxpayer Department (LTD), Mr. J. Kelly, Section Head, Operational Services Department (OSD) and Mr. N. Tacouri, Section Head Medium and Small Taxpayer Department (MSTD).
