MRA Blood Donation

MRA COLLECTS 1721 PINTS OF BLOOD

Since 2007, the Mauritius Revenue Authority (MRA) celebrates its anniversary by organising blood donation campaigns. This year the MRA Blood Donation took place on Tuesday 09 July at four collection points, namely the MRA Head Office, Ehram Court, Port Iouis, Custom House, Mer Rouge, PATS at Plaine Magnien, and at the Sir Seewoosagur Ramgoolam International Airport. Till date, the MRA has donated 10,561 pints of blood to the Blood Bank.

This event would not have been possible had it not been for the precious involvement and participation of blood donors from across the Island and the unconditional support of the Ministry of Health through the Blood Bank. Year in year out, the personnel of the Ministry go the extra mile to offer the best possible service to blood donners. As for the Ministry of Environment and that of the Local Government, they joined-in to make of the event a green one by donating fruit and flower plants to donors.



All the Municipalities and Local Authorities in Mauritius helped in promoting the event by displaying the information either on their respective electronic display boards or through banners. Friends of the media: radio, television, web TVs and the written press disseminated the information before and during the event. The Word of Mouth (WOM) effect, too, proved to be highly effective.





At the MRA, the organisation of the event had already begun six weeks before. The members of the Organising Committee met on various occasions, along with the representative of the Blood Bank to ponder on ways and means of improving this year's activity. On the day of the event, a whole team of MRA staff was in action since early in the morning to ensure that everything goes well. Others participated in the event without disturbing the daily service offered to customers.

WCO Scoping Mission

The Mauritius Revenue Authority (MRA) sought the assistance of the World Customs Organisation (WCO) to launch a full-fledged Customs Laboratory in Mauritius. A National Scoping Mission was, therefore, conducted by the WCO from Monday 08 to Friday 12 July, 2019 to evaluate the implementation of the Customs Laboratory. The mission met with concerned parties at the MRA Customs Department and Mr. V. Ramburun, Director of Customs, highlighted the importance of such a laboratory in terms of the implementation of 'Test Procedures' set out in the WTO Agreement on Trade Facilitation. The WCO Scoping Mission also met with stakeholders from other ministries to understand and study best practices performed by other governmental bodies.



Study Tour of Seychelles Delegation

Three delegates from the Seychelles Revenue Commission (SRC) conducted a study tour at the Mauritius Revenue Authority (MRA) from Monday 08 to Friday 12 July, 2019. The objective of the visit was to observe the human resources mechanisms in place at the MRA and to learn from same. The delegates paid a courtesy call on the Ag. Director-General, Mr. M.
