

The event began at 09h30 with the arrival of the Director General who was welcomed in fanfare by a parade of Customs Officers.

#### Drugs worth Rs. 119 million seized in March

The Mauritius Revenue Authority (MRA) and the Anti-Drug and Smuggling Unit (ADSU) jointly made six drug seizures in March. Heroin and synthetic drugs, worth Rs. 54 million and Rs. 65 million respectively, were seized at the SSR International Airport and Port Louis Harbour.



The biggest seizure of heroin, to the amount of around Rs. 34 million, was made on Wednesday 28 March, 2018. It was strapped to the body of a seaman of a cargo ship. The Narcotics Sniffer Dog 'Otto' reacted positively to the drugs.

2.5 kg of synthetic drugs seized in the same month constitute the biggest seizure of synthetic drugs made in March. The drugs were concealed in containers of protein supplements and were destined to an employee of a local bank.

#### **Double Taxation Agreement** between

#### Mauritius and Senegal

Two Senegalese officials were at the Mauritius Revenue Authority (MRA) in the context of negociations of a Double Tax Agreement (DTA) between Mauritius and Senegal, from 26 February to 02 March 2018. The Mauritian Delegation was headed by Mr. M. Hannelas, Director, Large Taxpayer Department (LTD). Negociations between both countries are still underway. The DTA aims, inter alia, at bettering the economic ties between Mauritius and Senegal.





## Taxpayers' Education: MRA collaborates with its
