THE CUSTOMS TARIFF ACT

Regulations made by the Minister under section 15 of the Customs Tariff Act

- **1.** These regulations may be cited as the Customs Tariff (Amendment of Schedule) (No. 5) Regulations 2021.
- 2. In these regulations
 - "Act" means the Customs Tariff Act.
- 3. The First Schedule to the Act is amended
 - (a) in Part I
 - (i) by deleting H.S. Code 3002.15.00 and its corresponding entries;
 - (ii) by inserting, in the appropriate numerical order, the H.S. Codes and their corresponding entries set out in the First Schedule to these regulations;
 - (iii) by deleting H.S. Codes 8702.40.91 and 8702.40.99 and their corresponding entries;
 - (iv) by inserting, in the appropriate numerical order, the H.S. Codes and their corresponding entries set out in the Second Schedule to these regulations;
 - (b) in Part II, in item E83, in the second column, by deleting the words ", a parastatal organisation or statutory body" and replacing them by the words "and any statutory corporation".

- **4.** (1) Regulation 3(a)(i) and (ii) shall be deemed to have come into operation on 10 April 2021.
- (2) Regulation 3(a)(iii) and (iv) shall come into operation on 15 September 2021.
