Formula as per Sixth Schedule to the Excise Act

For the purpose of Section 52B of the Excise Act, the computation of the amount to be paid shall be calculated in accordance with the below formula –

A= (R X Q) - P

Where:

- A is the amount of refund to be paid in a particular quarter of a calendar year;
- **R** is the rate of refund of
 - (A) 2,000 rupees per tonne for waste tyres exported, whether shredded or not, or recycled into reusable goods; or
 - (B) 25 rupees for any tyre retreaded locally;
- **Q** is the sum of the quantity of waste tyres exported, whether shredded or not or recycled into reusable goods, for the quarter in respect of which the amount to be refunded is claimed and the quantity of all export made or quantity recycled for the previous quarters in that calendar year;
- **P** is the amount already refunded by the Director-General in that calendar year.
