

MRA negotiates **DTAA** with Angola

A delegation of three senior officials from Angola General Tax Administration, headed by Mr. José Dinis DUNGO, Administrator of the Angola General Tax Administration was at the Mauritius Revenue Authority (MRA) from 04 to 06 November 2019. The purpose of their visit was to negotiate the Double Taxation Avoidance Agreement (DTAA) between Mauritius and Angola.



The MRA team was headed by Mr. Mario Hannelas, Director, Large Taxpayer Department. The negotiation culminated with the agreement being initialled by both parties. .



On the same occasion, the Angolan delegation paid a courtesy visit on Mr. Sudhamo Lal, the Director-General of the MRA.



Launching of the 'Certificate in Import & Export Procedures'

The 'Certificate in Import and Export Procedures' was officially launched by Prof. D. Jhurry at the Core Building on 4 November 2019. This course will be of benefit to customs clerks and customs brokers.







The project was initiated by Mrs Lilowtee Rajmun-Joosery, Director, Mauritius Export Association (MEXA) and found the collaboration of the University of Mauritius (UoM) and the Mauritius Revenue Authority (MRA) to offer the technical modules to professionalise the job of people involved in the import and export chain.

Three-Day Workshop on Intellectual Property Rights

A workshop on Intellectual Property Rights (IPR) was organised at the Custom House from Tuesday 19 to Thursday 21 November 2019. The training was dispensed by both local and foreign resource persons from the following companies: KUASA, REACT, Adams and Adams, Eversheds-Sutherland, IVOCATE Africa Ltd and Geroudis. Those firms represent a certain number of registered trademarks in Mauritius.



The objective of the workshop was to train customs officers on new techniques of detecting IPR infringed goods at borders.

Educational Sessions for the Manufacturing Sector

Four half-day tax training sessions were organised for the Manufacturing Sector at the request of the Mauritius Export Association (MEXA) from 13 to 18 November 2019 at the Gold Crest Hotel, Quatre Bornes.

The MRA provided resource persons who delivered the training on Corporate Tax, Objections & Appeal, Corporate Social Responsibility, Freeport and Value Added Tax.

Miss Nalina Sungeelee, Technical Officer at the Large Taxpayer Department of the MRA, was awarded a Chevening Scholarship for the year 2018-2019. Chevening is the UK government's renowned awards programme that enables promising young professionals around the world since 1983 to grow academically and network intensively to become future leaders and decision-makers.

Nalina successfully completed her L.L.M. in International Tax Law in November 2019 from King's College London, one of the oldest and most prestigious universities in the UK under Professor Jonathan Schwarz, a leading barrister in cross-border tax disputes. Nalina studied International Tax Law, UK Tax Law, EU Tax Law and Transfer Pricing, obtaining distinctionlevel in three out of four papers. She undertook her final project in Transfer Pricing, for which she developed a keen interest and in which she now aims to acquire practical expertise. She is currently posted at the International Tax Section, where she will be contributing to the Section's efforts to meet Mauritius's commitments on the international fiscal scene.

During her year as a Chevening Scholar, she attended various workshops and scholar events organised by King's College London and the Chevening Secretariat around the UK and in Europe that allowed her to network and broaden her outlook on different topics. Her best takeaway from her year abroad are the friendships she has built with tax professionals from all over the world working for governments, international organisations and the private sector.


