

PAYMENT TO THE DIRECTOR-GENERAL OF THE PROCESSING FEE FOR BILLS OF ENTRIES / ENTRIES FOR EXCISABLE GOODS

FURTHER TO NOTICES DATED 22 AUGUST 2025 AND 01 OCTOBER 2025 ISSUED ON THE ABOVE SUBJECT, TRADENET USERS ARE HEREBY INFORMED THAT AMENDMENTS ARE BEING MADE TO THE CUSTOMS REGULATIONS 1989 TO PROVIDE THAT THE COLLECTION AND REMITTANCE OF THE PROCESSING FEE SHALL BE THE RESPONSIBILITY OF THE TRADENET USER THROUGH WHOSE SYSTEM THE BILL OF ENTRY / ENTRY FOR EXCISABLE GOODS HAS BEEN PROCESSED.

HENCE, AT THE BEGINNING OF EVERY MONTH, EACH TRADENET USER SHALL BE PROVIDED, VIA THE EMAIL THEY HAVE COMMUNICATED TO CUSTOMS, AN INVOICE SPECIFYING THE NUMBER OF BILLS OF ENTRY/ ENTRY FOR EXCISABLE GOODS PROCESSED BY HIM AND THE CORRESPONDING AMOUNT OF PROCESSING FEES ACCRUED DURING THE PREVIOUS MONTH.

THE TRADENET USER SHALL REMIT THE AMOUNT OF PROCESSING FEE COLLECTED TO CUSTOMS WITHIN THIRTY (30) WORKING DAYS AFTER THE END OF EVERY MONTH DURING WHICH THE PROCESSING FEES HAVE ACCRUED.

FOR PROPER IMPLEMENTATION OF THIS MEASURE, EACH TRADENET USER SHALL ENSURE THAT THE EMAIL ADDRESS COMMUNICATED TO MRA CUSTOMS, TO WHICH THE MONTHLY INVOICE WILL BE SENT, IS CORRECT. IN CASE OF CHANGE IN EMAIL ADDRESS, A TRADENET USER IS REQUIRED TO COMMUNICATE BY **15 SEPTEMBER 2026** HIS NEW EMAIL ADDRESS TO MRA CUSTOMS AT: stakeholders.customs@mra.mu

TRADENET USERS ARE ALSO **REMINDED** THAT TO EFFECT PAYMENT TO THE DIRECTOR-GENERAL OF THE PROCESSING FEE FOR BILLS OF ENTRY/ENTRIES FOR EXCISABLE GOODS, THE FOLLOWING PAYMENT OPTIONS MAY BE CONSIDERED –

- (1) CASH OR CHEQUE DRAWN TO “MAURITIUS REVENUE AUTHORITY”;
- (2) TRADENET ELECTRONIC PAYMENT SYSTEM (TEPS); OR
- (3) E-SERVICE “MOBILE PAYMENT OF DUTIES AND TAXES”, AVAILABLE AT: <https://www.mra.mu/index.php/eservices1/customs>

TRADENET USERS ARE ALSO REQUESTED TO KEEP A RECORD OF BILLS OF ENTRY / ENTRIES FOR EXCISABLE GOODS PROCESSED DURING A MONTH WHICH MAY BE RECONCILED WITH THE INVOICE ISSUED BY CUSTOMS.
