

NOTICE TO OPERATORS

ARTICLES RE-IMPORTED AFTER REPAIRS

ECONOMIC OPERATORS ARE HEREBY INFORMED THAT -

(A) NEW ITEM E6 HAS BEEN INTRODUCED IN PART II OF THE FIRST SCHEDULE TO THE CUSTOMS TARIFF ACT TO PROVIDE THAT, FOR ARTICLES RE-IMPORTED AFTER REPAIRS, NO CUSTOMS DUTY SHALL BE CHARGED ON THE VALUE OF THE REPAIRS PROVIDED THAT THE CONDITIONS AS PER THE ITEM E6 HAVE BEEN COMPLIED WITH.

HOWEVER, VAT AT IMPORT SHALL BE APPLICABLE AS PER ITEM 22 OF THE FIRST SCHEDULE TO THE VALUE ADDED TAX ACT.

(B) FOR THE PROPER IMPLEMENTATION OF THE MEASURE AT PARAGRAPH (A), THE DESCRIPTIONS OF THE CUSTOMS PROCEDURE CODES (CPCs) 62000, 62008 AND 67000 ARE BEING MODIFIED AS PER TABLE 1 BELOW -
