NOTICE TO ECONOMIC OPERATORS

FREEPORT (AMENDMENT OF SCHEDULE) REGULATIONS 2019 (G.N. No. 200 OF 2019)

ADDITION OF NEW FREEPORT ZONES 26, 27 AND 28 AND DELETION OF FREEPORT ZONES 18 AND 24 AS FROM 26 OCTOBER 2019

ECONOMIC OPERATORS ARE HEREBY INFORMED THAT AMENDMENTS HAVE BEEN BROUGHT TO THE FIRST SCHEDULE OF THE FREEPORT ACT AS PER THE FREEPORT (AMENDMENT OF SCHEDULE) REGULATIONS 2019 (GOVERNMENT NOTICE NO. 200 OF 2019) BY –

- A. **DELETING ZONES 18 AND 24 AND THEIR CORRESPONDING ENTRIES; AND**
- B. **ADDING NEW ZONES 26, 27 AND 28 AND THEIR CORRESPONDING ENTRIES.**

TO IMPLEMENT THE ABOVE MEASURE –

- (I) **FOR THE PURPOSE OF PROCESSING BILLS OF ENTRY FOR THE NEW FREEPORT ZONES UNDER PARAGRAPH B ABOVE, THE DECLARANTS HAVE TO USE THE APPROPRIATE WAREHOUSE CODES AND FREEPORT ZONE CODES AS PER TABLE BELOW:**

(II) UNDER PARAGRAPH A ABOVE -

- (1) THE WAREHOUSE CODES **FP18, UL01 AND LM18** AND THE FREEPORT ZONE CODES **MCF18, FPZ18 AND LMC18** ARE BEING **DEACTIVATED** FOR THE DELETED **ZONE 18**; AND
- (2) THE FREEPORT ZONE CODE **FPZ24 – TRADE PARK MON TRESOR LTD** IS BEING **DEACTIVATED** FOR THE DELETED **ZONE 24**.
