

NOTICE TO DECLARANTS AND IMPORTERS

CREATION OF NEW CUSTOMS PROCEDURE CODES (CPCs) FOR IMPORT OF GOODS BY COMPANY HOLDING A PDS CERTIFICATE FOR THE SENIOR LIVING PROJECT

FURTHER TO THE ENACTMENT OF THE INVESTMENT PROMOTION (PROPERTY DEVELOPMENT SCHEME) (AMENDMENT) REGULATIONS 2019 (GN No. 80 OF 2019), DECLARANTS AND IMPORTERS ARE HEREBY INFORMED THAT THE FOLLOWING NEW CUSTOMS PROCEDURE CODES (CPCs) HAVE BEEN CREATED TO CATER FOR CUSTOMS DUTY EXEMPTION UNDER NEW REGULATION 18A(2) OF THE INVESTMENT PROMOTION (PROPERTY DEVELOPMENT SCHEME) REGULATIONS 2015.

THE CUSTOMS DUTY EXEMPTION IS WITH RESPECT TO IMPORT OF:

- (A) GOODS, OTHER THAN FURNITURE, TO BE USED IN THE INFRASTRUCTURE WORKS AND CONSTRUCTION OF BUILDINGS; AND
- (B) FURNITURE UNDERGOING FURTHER PROCESSING RESULTING INTO VALUE ADDITION OF AT LEAST 20 PER CENT OF THE C.I.F. VALUE AT IMPORT,

IMPORTED BY COMPANY HOLDING A PDS CERTIFICATE FOR THE SENIOR LIVING PROJECT.
