

## NOTICE TO ECONOMIC OPERATORS

## IMPLEMENTATION OF MEASURES AS PER THE FINANCE ACT 2025 -

- (1) CAMERAS FOR CCTV SYSTEMS UNDER H.S CODE 8525.89.10 (VAT AT ZERO-RATE)
- (2) EXCISE DUTY ON THE SUGAR CONTENT OF CHOCOLATES AND ICE CREAM

ECONOMIC OPERATORS ARE HEREBY INFORMED OF THE FOLLOWING MEASURES LAID DOWN UNDER THE FINANCE ACT 2025 (**ACT NO. 18 OF 2025**), WHICH SHALL COME INTO OPERATION ON **01 OCTOBER 2025** -

## (1) CAMERAS FOR CCTV SYSTEMS UNDER H.S CODE 8525.89.10 (VAT AT ZERO-RATE)

FURTHER TO PARAGRAPH (1) OF NOTICE ISSUED ON 12 AUGUST 2025, AMENDMENTS SHALL BE MADE TO PART I OF THE FIRST SCHEDULE TO THE CUSTOMS TARIFF ACT –

- (a) BY DELETING THE H.S. CODE SPECIFIED IN PART I OF **ANNEX I**;
- (b) BY INSERTING, IN THE APPROPRIATE NUMERICAL ORDER, THE H.S. CODES SPECIFIED IN PART II OF **ANNEX I**;

CONSEQUENTLY, CUSTOMS PROCEDURE CODES (CPCs) 40CAM, 47CAM AND 49CAM SHALL BE DEACTIVATED WITH THE COMING INTO OPERATION OF THE H.S CODE 8525.89.10 (CAMERAS FOR CCTV SYSTEMS).

## (2) EXCISE DUTY ON THE SUGAR CONTENT OF CHOCOLATES AND ICE CREAM

AMENDMENTS SHALL BE MADE TO PART I OF THE FIRST SCHEDULE TO THE CUSTOMS TARIFF ACT AND PART I OF THE FIRST SCHEDULE TO THE EXCISE ACT –

- (a) BY DELETING THE H.S. CODES SPECIFIED IN PART I OF ANNEX II:
- (b) BY INSERTING, IN THE APPROPRIATE NUMERICAL ORDER, THE H.S. CODES SPECIFIED IN PART II OF **ANNEX II**;
