

## CUSTOMS DEPARTMENT NOTICE TO DECLARANTS/IMPORTERS

## NEW CPC FOR THE WAREHOUSING OF MOTOR VEHICLES FOR THE TRANSPORT OF GOODS ('B' CARRIER'S LICENCE)

(1) DECLARANTS AND IMPORTERS ARE HEREBY INFORMED THAT NEW CUSTOMS PROCEDURE CODE (CPC) FOR MOTOR VEHICLES THAT NORMALLY BENEFIT FROM EXCISE DUTY EXEMPTION UNDER ITEM 8 OF SUB-PART A OF PART IA TO THE FIRST SCHEDULE OF THE EXCISE ACT IS BEING CREATED TO FACILITATE CUSTOMS PROCEDURE RELATED TO THE WAREHOUSING OF THESE GOODS. THE UNDER-MENTIONED NEW CPC SHALL BE EFFECTIVE AS FROM 8<sup>TH</sup> FEBRUARY 2021:

(2) DECLARANTS AND IMPORTERS SHALL ENSURE THAT THE CPC 70X08 ARE USED FOR:

- (A) VAN TYPE VEHICLE WITH ANCHOR POINTS (WITHOUT REAR SEATS), INTENDED TO BE CLEARED **ONLY** FOR TRANSPORT OF GOODS ('B' CARRIER'S LICENCE) ARE TO BE CLASSIFIED IN THE APPROPRIATE TARIFF HEADING 87.03; OR
- (B) MOTOR VEHICLES OF THE UNDER-MENTIONED HS CODES -
