### NOTICE TO ECONOMIC OPERATORS

#### **CONSOLIDATED BILL OF ENTRY FOR GOODS (MERCHANDISE FOR SALE) IMPORTED/EXPORTED BY POST AND COURIER SERVICES AND LOCALLY MANUFACTURED SUGAR SWEETENED PRODUCTS**

ECONOMIC OPERATORS ARE HEREBY INFORMED THAT THE FINANCE (MISCELLANEOUS PROVISIONS) ACT 2021 (ACT NO. 15 of 2021) HAS AMENDED:

- (A) THE CUSTOMS ACT BY INTRODUCING NEW SECTIONS 30(5) AND 92(4); AND
- (B) THE EXCISE ACT BY INTRODUCING NEW SECTION 4(3),

WHICH PROVIDE FOR IMPORTERS/ EXPORTERS/ MANUFACTURERS TO SUBMIT A CONSOLIDATED BILL OF ENTRY FOR GOODS (MERCHANDISE FOR SALE) IMPORTED / EXPORTED BY POST AND COURIER SERVICES AND LOCALLY MANUFACTURED SUGAR SWEETENED PRODUCTS.

THIS MEASURE SHALL COME INTO OPERATION ON **1 OCTOBER 2021**.
