

NOTICE TO ECONOMIC OPERATORS

## **IMPLEMENTATION OF MEASURES IN BUDGET SPEECH 2023-2024**

ECONOMIC OPERATORS ARE HEREBY INFORMED THAT FOLLOWING THE PRESENTATION OF THE **2023-2024 BUDGET** BY DR. THE HON. MINISTER OF FINANCE, ECONOMIC PLANNING AND DEVELOPMENT, THE FOLLOWING MEASURES ARE BEING **IMPLEMENTED**:

- (1) (A) THE FIFTH SCHEDULE TO THE VAT ACT (<u>VAT AT ZERO-RATE</u>) IS BEING AMENDED BY ADDING THE FOLLOWING NEW ITEMS:
  - NOODLES;
  - TOOTHPASTES;
  - TOOTHBRUSHES;
  - BABY WIPES;
  - NAPKINS (DIAPERS) AND NAPKIN LINERS FOR BABIES;
  - BABY POWDERS;
  - BABY CREAMS;
  - BREAST PUMPS;
  - INFANT FEEDING BOTTLES;
  - EXERCISE BOOKS;
  - PENCILS;
  - CRAYONS;
  - ERASERS;
  - WALKING STICKS;
  - INCONTINENT MATTRESS PADS;
  - MUSICAL INSTRUMENTS, PARTS AND ACCESSORIES;
  - INSTRUMENTS, APPLIANCES AND APPARATUS USED IN MEDICAL, SURGICAL, DENTAL OR VETERINARY SCIENCES, OF HEADING 90.18;
  - MEDICAL GRADE SILICONE; AND
  - GLASS-CERAMIC BLOCKS FOR DENTAL USE
  - (B) CUSTOMS DUTY (15%) IS ALSO BEING REMOVED ON GLASS-CERAMIC BLOCKS FOR DENTAL USE.
- (2) FOR THE PROPER IMPLEMENTATION OF THE ABOVE MEASURES AT PARAGRAPH (1)(A) AND (B), THE INTEGRATED TARIFF IS BEING AMENDED -
  - (I) BY DELETING THE H.S. CODES SPECIFIED IN PART I OF **ANNEX I**;
  - (II) BY INSERTING, IN THE APPROPRIATE NUMERICAL ORDER, THE H.S. CODES SPECIFIED IN PART II OF **ANNEX I**;

## THE ABOVE MEASURE SHALL BE EFFECTIVE AS FROM <u>05<sup>th</sup> JUNE 2023.</u>
