

NOTICE TO ECONOMIC OPERATORS

IMPLEMENTATION OF BUDGETARY MEASURES WITH RESPECT TO CUSTOMS DUTY AND VAT EXEMPTIONS

FURTHER TO THE GAZETTING OF THE FINANCE (MISCELLANEOUS PROVISIONS) ACT 2021 (ACT NO. 15 of 2021), DECLARANTS AND IMPORTERS ARE HEREBY INFORMED THAT, -

- (1) CPCS, 40V21, 47V21, 49V21, 40V23, 47V23, 49V23, 40V24, 47V24 AND 49V24 ARE BEING DEACTIVATED AS FROM 1ST SEPTEMBER 2021:
