COVID-19 HOME SELF TESTING KIT

- (1) ECONOMIC OPERATORS ARE HEREBY INFORMED OF THE FOLLOWING AMENDMENTS BEING MADE TO THE **CONSUMER PROTECTION (CONTROL OF IMPORTS) REGULATIONS 2017** -
 - (A) THE FOURTH SCHEDULE (*RESTRICTED GOODS*) TO THE REGULATIONS IS AMENDED BY INSERTING, IN THE APPROPRIATE NUMERICAL ORDER, THE FOLLOWING NEW ITEMS AND THEIR CORRESPONDING ENTRIES –

H.S Code	Description
3002.15.10	COVID-19 Home Self-Testing Kit
3822.00.20	COVID-19 Home Self-Testing Kit

(B) THE SIXTH SCHEDULE TO THE REGULATIONS IS AMENDED BY ADDING THE FOLLOWING NEW ITEM AND ITS CORRESPONDING ENTRIES –

 - (A) DELETING THE H.S. CODE AND ITS CORRESPONDING ENTRIES SPECIFIED IN **PART A** OF **ANNEX I**; AND
 - (B) INSERTING, IN THE APPROPRIATE NUMERICAL ORDER, THE H.S CODES AND THEIR CORRESPONDING ENTRIES SPECIFIED IN **PART B** OF **ANNEX I**.

KINDLY NOTE THAT **ANNEX I** IS IN THE FORMAT OF THE INTEGRATED TARIFF.
