

## IMPLEMENTATION OF BUDGETARY MEASURES AS MENTIONED IN THE FINANCE (MISCELLANEOUS PROVISIONS) ACT 2017

FOLLOWING THE GAZETTING OF THE ABOVE-MENTIONED ACT, IMPORTERS AND DECLARANTS ARE HEREBY INFORMED THAT THE ACT HAS, INTER ALIA, AMENDED THE FOLLOWING ENACTMENTS:

- (A) PART II OF THE FIRST SCHEDULE TO THE CUSTOMS TARIFF ACT IN ITEM E95, IN THE THIRD COLUMN, BY THE ADDITION OF THE FOLLOWING NEW PARAGRAPH, THE EXISTING PROVISION BEING NUMBERED AS PARAGRAPH (1)
  - (2) SCAFFOLDING, SHUTTERING, PROPPING OR PIT-PROPPING EQUIPMENT MADE OF WOOD OR PLASTIC

CONSEQUENTLY, CUSTOMS PROCEDURE CODES 40ET2, 47ET2 AND 49ET2 HAVE BEEN DEACTIVATED.

## (B) PART IA OF THE FIRST SCHEDULE TO THE EXCISE ACT BY THE ADDITION OF NEW ITEM 79

TO IMPLEMENT THE ABOVE PROVISION, THE FOLLOWING CUSTOMS PROCEDURE CODES –

- (I) 40ET3, 47ET3 AND 49ET3 HAVE BEEN DEACTIVATED; AND
- (II) AS SET FORTH IN THE UNDER-MENTIONED TABLE HAVE BEEN CREATED

## (C) FIRST SCHEDULE TO THE VALUE ADDED TAX ACT BY THE ADDITION OF THE FOLLOWING HS CODES-

- (I) 2201.90.20; AND
- (II) 8452.30.00

TO IMPLEMENT THE ABOVE PROVISION, AMENDMENT HAS BEEN BROUGHT TO THE INTEGRATED TARIFF BY:

- (A) DELETING THE HS CODES SPECIFIED IN PART A OF ANNEX 1; AND
- (B) INSERTING, IN THE APPROPRIATE NUMERICAL ORDER, THE HS CODES AND ITS CORRESPONDING ENTRIES IN PART B OF ANNEX 1.
