NEW CPCs FOR IMPORT OF GOODS BY A COMPANY HOLDING A PDS CERTIFICATE FOR THE SENIOR LIVING PROJECT UNDER REGULATION 18A(2) OF THE INVESTMENT PROMOTION (PROPERTY DEVELOPMENT SCHEME) REGULATIONS 2015

FURTHER TO THE NOTICES TO DECLARANTS AND IMPORTERS DATED 10.05.2019 AND 20.01.2020, DECLARANTS AND IMPORTERS ARE HEREBY INFORMED THAT NEW CUSTOMS PROCEDURE CODES (CPCs), AS PER TABLE BELOW, ARE BEING CREATED TO CATER FOR CUSTOMS DUTY EXEMPTION ONLY FOR A PDS COMPANY IMPLEMENTING A PROJECT RELATING TO SENIOR LIVING UNDER REGULATION 18A(2) OF THE INVESTMENT PROMOTION (PROPERTY DEVELOPMENT SCHEME) REGULATIONS 2015 AND WHICH DOES NOT HOLD A REGISTRATION CERTIFICATE FROM THE ECONOMIC DEVELOPMENT BOARD (EDB):

3	49PDC	IMPORT FROM FREEPORT OF ANY DUTIABLE GOODS, OTHER THAN FURNITURE, BY A COMPANY HOLDING A PDS CERTIFICATE, TO BE USED IN THE INFRASTRUCTURE WORKS AND CONSTRUCTION OF BUILDINGS RELATING TO SENIOR LIVING PROJECTS - CUSTOMS DUTY EXEMPTED
