CPCs FOR CLEARANCE OF GOODS IMPORTED BY A REGISTERED NRP DEVELOPER

DECLARANTS AND IMPORTERS ARE HEREBY INFORMED THAT PURSUANT TO THE INVESTMENT PROMOTION (SMART CITY SCHEME) (AMENDMENT) REGULATIONS 2018 (GOVERNMENT NOTICE NO. 174 OF 2018), NEW CUSTOMS PROCEDURE CODES HAVE BEEN CREATED AS PER THE TABLE BELOW FOR THE CLEARANCE OF DUTIABLE GOODS AND FURNITURE IMPORTED BY REGISTERED NATIONAL REGENERATION PROGRAMME (NRP) DEVELOPER.

2	47NRG	EXWAREHOUSING OF ANY DUTIABLE GOODS, OTHER THAN FURNITURE, TO BE USED IN INFRASTRUCTURE WORKS AND CONSTRUCTION OF BUILDINGS BY A NRP DEVELOPER DULY REGISTERED WITH THE EDB UNDER THE NATIONAL REGENERATION PROGRAMME - CUSTOMS DUTY NOT PAYABLE.
