

NOTICE TO STAKEHOLDERS

DECLARANTS, IMPORTERS AND MANUFACTURERS OF PLASTIC BAGS ARE HEREBY INFORMED THAT WITH EFFECT FROM 1 JANUARY 2016 -

- (i) A <u>SCANNED COPY</u> OF THE DULY APPROVED REGISTRATION DOCUMENT, OBTAINED FROM THE DIRECTOR OF ENVIRONMENT PURSUANT TO REGULATION 5, NEED TO BE SUBMITTED WITH BILL OF ENTRY FOR EXEMPTED PLASTIC BAGS AS PER ITEMS (a) TO (i) OF THE FIRST SCHEDULE TO GN NO. 153 OF 2015 AS AMENDED BY GN NO. 233 OF 2015 REFERRED TO IN TABLE 2 BELOW.
- (ii) A <u>CLEARANCE</u>, FROM THE DIRECTOR OF ENVIRONMENT PURSUANT TO REGULATION 5A, NEED TO BE SUBMITTED WITH BILL OF ENTRY FOR PLASTIC BAGS AS PER ITEMS (j) AND (k) OF THE FIRST SCHEDULE TO GN NO. 153 OF 2015 AS AMENDED BY GN NO. 233 OF 2015 REFERRED TO IN TABLE 2 BELOW.
- (iii) <u>BIODEGRADABLE</u> AND <u>COMPOSTABLE</u> PLASTIC BAGS, AS PER ITEMS (j) AND (k) OF THE FIRST SCHEDULE TO GN NO. 153 OF 2015 AS AMENDED BY GN NO. 233 OF 2015 REFERRED TO IN TABLE 2 BELOW, <u>WHICH CONFORM TO STANDARDS</u> SPECIFIED IN THE SECOND SCHEDULE OF GN NO. 233 OF 2015 WILL BE EXEMPTED FROM PAYMENT OF EXCISE DUTY OF TWO RUPEES PER PLASTIC BAG.
- (iv) <u>BIODEGRADABLE</u> AND <u>COMPOSTABLE</u> PLASTIC BAGS, AS PER ITEMS (j) AND (k) OF THE FIRST SCHEDULE TO GN NO. 153 OF 2015 AS AMENDED BY GN NO. 233 OF 2015 WILL BE INCLUDED UNDER ITEM 51 OF PART 1A OF THE FIRST SCHEDULE TO THE EXCISE ACT.
