### **Initiating Students to Taxation**

The Mauritius Revenue Authority (MRA) organized an educational tour at the Integrated Customs Clearance Centre (ICCC) on Friday, 1st of March 2024. Some 200 students from different colleges, namely Loreto Convent and Hamilton College, in Mahebourg, Sookdeo Bissoondoyal SSS in Rose Belle and France Boyer de La Giroday SSS in Plaine Magnien interacted with the MRA team. They enjoyed enlightening presentations and educational videos on diverse tax subjects, and explored real-life case studies on taxation.



With an objective to instilling a tax culture based on voluntary compliance, MRA has since its inception set up a dedicated department, the Taxpayer Education and Communication Department (TECD) within its organisational structure. MRA's mandate is to enhance tax adherence through educational initiatives. Its educational approach is diverse, encompassing sessions for major taxpayers, SMEs, the general public, and high school students, potential taxpayers of tomorrow.

The ultimate objective of MRA's education strategy is to gradually shift attitudes from viewing tax payment as an obligation to seeing it as a voluntary contribution in nation building,

#### Over 10,000 students sensitised on taxation

For the past 5 years, MRA has conducted some two hundred sessions in secondary institutions, reaching more than 10,000 students. MRA is confident that this initiative will further reinforce the moral duty to voluntarily pay taxes, leading to a positive shift towards a greater willingness to fulfil tax obligations in the long term.

#### Taxes are the lifeblood of our society

During his keynote address at the event, Mr. Sudhamo Lal, Director-General of MRA, emphasized that voluntary compliance is essential for a successful tax system. This entails taxpayer's meeting their tax responsibilities without the necessity of enforcement actions, thus fostering trust and mutual respect between taxpayers and the tax authority.

#### Voluntary compliance cultivates a culture of transparency and integrity

Voluntary compliance conveys a strong message that each individual is responsible for their actions and is committed to upholding principles of fairness and honesty. By willingly disclosing their income and paying the correct amount of tax, taxpayers save themselves from potential penalties and audits, while also enabling the Government to allocate resources more



efficiently towards public services, Mr. Lal underlined in his keynote address to the students.

For the Director-General, "taxes go beyond being a mandatory financial responsibility enforced by the government; they serve as the vital foundation of our society. They provide the necessary funding for crucial public services like education, healthcare, infrastructure, and social welfare initiatives."

#### Breakthrough innovation as a mantra for success

Breakthrough innovation is a mantra at MRA, positioning the Organisation to be ahead of time, by constantly seeking new ways of administrating taxation. During his speech, Teeluckdharry, Assistant Director, at TECD, emphasized the need for organizations to embrace a culture of creativity and innovation in

view of staying ahead of the curve. By embracing innovation, MRA has been able to adapt to changing environments, and ultimately achieve greater efficiency and effectiveness in revenue collection.



Dr. Rakesh Thecka, Team Leader at TECD, made a presentation on the role of MRA in the Mauritian economic lanscape, highlighting the myriads of taxation administered by the organisation. He stressed the importance of the different types of taxes and the revenue that they generate. On another score, Dr. Thecka dwelt on practical examples and discussed the implications of taxation on individuals and businesses. The students gained a deeper understanding taxation, and its important role in the implementation of socio-economic projects.



Feedback was gathered from the students on the education tour, bridging the gap between theoretical knowledge and the practical application of taxation in our daily lives.
