MRA Welcomes Newly Appointed Officers After One-Year Traineeship

The Mauritius Revenue Authority (MRA) marked a significant milestone as it formally appointed its latest cohort of officers following the successful completion of a comprehensive one-year traineeship. The Passing-Out Ceremony, held at the MRA Headquarters, brought together the Director-General of the MRA, Mr. Rohit Ramnawaz, senior management, departmental directors, training facilitators, and the newly appointed officers. The event celebrated the conclusion of an intensive learning journey and the beginning of a career in public service committed to fairness, professionalism, and national development.



The Director-General's Call to Duty

In his keynote address, Mr. Rohit Ramnawaz, Director-General of the MRA, congratulated the new officers on the successful completion of their one-year traineeship and welcomed them into the ranks of the organisation. He reminded them of the crucial role the MRA plays in national life, collecting around 90 percent of the government's annual revenue, funds that support essential public services such as roads, schools, hospitals, and other infrastructure. He noted that the organisation's mission is not to harass taxpayers but to ensure that those who can and should pay their taxes do so, so that the state can ensure the sustainability of public services and the welfare state. "We must carry out this role without bias and without preference," he affirmed.

Calling on officers to see themselves as part of the backbone of fiscal governance, Mr. Ramnawaz emphasised that their work directly strengthens the country. "Every rupee you help collect contributes to the nation's growth and well-being. Wear this responsibility with pride and remember that you are serving not just the MRA, but Mauritius," he stated.

He concluded by highlighting the need to embrace change and innovation. With digital transformation, data analytics, and artificial intelligence becoming key tools, he encouraged the officers to adapt and lead in using technology to improve efficiency, transparency, and taxpayer service and ensuring that the MRA remains a pillar of fiscal stability for the Republic.



Addressing the officers, Mr. Geerjanand P. Ramkissoon, Director of the Objections, Appeals, and Dispute Resolution Department, outlined the varied and demanding roles they will now assume across the MRA. Mr. Ramkissoon reminded them that tax officers are entrusted with safeguarding the integrity of the fiscal system.
