

RENEWAL OF LICENCES FOR SALE OF BEER, RUM, LIQUOR & ALCOHOLIC PRODUCTS FOR THE YEAR 2026

Holders of Licences (including Licence holders in Rodrigues) for wholesale/retail sale of Beer, Rum, Liquor and Alcoholic Products are informed that **Payment of the Licence Fees for the Renewal of the Licences for Year 2026** may be effected **electronically** using the facility available on the MRA website: www.mra.mu.

Licensees are also informed that, following changes brought by the Finance Act 2025 to the Excise Act, the fees payable for the year 2026 are as follows:

| 5. | Retailer of Liquor and Alcoholic Products - Hotel and Guest House (On and Off) | 4,000 |
| 6. | Retailer of Liquor and Alcoholic Products - Restaurant (On) | 8,000 |
| 7. | Retailer of Liquor - Private Club (On) | 4,000 |
| 8. | Retailer of Liquor - Night Club (On) | 8,000 |
| 9. | Retailer of Liquor and Alcoholic Products - Casino or Gaming House (On) | 12,000 |
| 10. | Retailer of Beer, Alcoholic Beverages, Alcoholic Products and Liquor - Pub (On) | 8,000 |
| 11. | Retailer of Beer, Alcoholic beverages, Alcoholic Products and Liquor - Table d'Hôte (On) | 4,000 |

Holders of Licences listed at items 5,6,7,8,10 and 11 as per table above, must ensure that they have a valid **Tourist Enterprise Licence (TEL) or Tourist Accommodation Certificate (TAC)** from the Tourism Authority for the **Year 2026**, when renewing their Liquor Licences.

Holders of **Wholesale** Licences as "Dealer in Liquor and Alcoholic Products" must ensure that they have already furnished to the MRA the required **Security by means of a Bond**, prior to availing themselves of the online payment facility for the renewal of their Liquor Licences.

Any Licence renewed after Wednesday, 14 January 2026 will be subject to a Surcharge of 50%.
