#### **Taxpayer Satisfaction Survey 2023:**

#### MRA HONOURS THE WINNERS

The winners of the Taxpayer Satisfaction Survey (TSS) Draw received their respective cheques on Tuesday 5<sup>th</sup> of December 2023, at the seat of the Mauritius Revenue Authority (MRA) Head Office, Ehram Court, Port-Louis.

The first prize, a cash prize of Rs. 25,000, went to Mr. Shah Muhammad Jaleel Kurreembukus, whilst, Mr. Jayecoomar Dooky and Mr. Dhinesh Cahoolessur won the second prize of Rs. 15,000, and the third prize of Rs. 10,000, respectively.

In his keynote address, Mr. Dhanraj Ramdin, Acting Director-General of MRA, emphasized the organization's commitment to embracing digital transformation. He shed light on MRA's ongoing efforts to enhance its services through digitalisation, ultimately aiming to simplify processes, improve efficiency, and provide a seamless experience for taxpayers. Mr. Ramdin also pointed out that Mauritius ranked at the 5<sup>th</sup> position in the ease of paying taxes index in the World Bank Report, owing to the sustained reforms implemented by the MRA.

For his part, Mr. Roshan Oree, Assistant Director, Research, Policy and Planning Department, MRA, highlighted that MRA had received more than 32,000 valuable comments and suggestions from taxpayers. He further emphasized that "every comment and suggestion received from taxpayers is being carefully taken into consideration by MRA because the organization values the input provided by taxpayers and understands that their firsthand experiences can offer valuable insights into areas that require attention and improvement."

Mr. Amick Teeluckdharry, Assistant Director, Taxpayer Education and Communication Department (TECD) indicated that "the outcome of the Taxpayer Satisfaction Survey conducted till date has allowed MRA to improve the quality of the services it offers to taxpayers year-in, year-out." The ongoing digital transformation of MRA's services will, no doubt, lead to a more efficient and user-friendly tax system in Mauritius, he concluded.

The outcome of the survey was presented to the MRA Management Team. Based on the feedback received, actions are being initiated at different levels to improve the quality of the various services offered.

# RS. 28 MILLION OF SYNTHETIC DRUGS SEIZED AT A COURIER SERVICE

The Mauritius Revenue Authority (MRA), in collaboration with the Anti-Drug Smuggling Unit (ADSU), seized circa 1880g of synthetic drugs worth more than Rs. 28 Million at a Courier service on 06 December 2023.

A parcel declared as food supplements was selected for examination by MRA CANS Officers based on established risk indicators, along with ADSU Officers. The parcel was scanned and it was found to contain one aluminum sachet with a certain quantity of a brownish powder inside, another aluminum sachet and one plastic sachet each containing a certain quantity of an off-white powder.

A field test for synthetic drug was carried out and same was positive.

A controlled delivery operation was set up by ADSU. Three persons have been arrested during the controlled delivery exercise. One of the arrested persons was found to be in possession of a firearm with live ammunitions.

This significant seizure is again a testament to the effectiveness of MRA's strategies in detecting and preventing the illegal importation of drugs into Mauritius.

MRA remains steadfast in its commitment to safeguarding the well-being and safety of its citizens by actively working to eradicate the drug trade within the country. MRA, therefore, reiterates its appeal to the members of the public to report suspected drug cases/ illicit activities to MRA through the MRA Stop Drug Platform (www.mra.mu), or by calling on the Hotline 8958.



#### MRA in the Media:

#### **RADIO/TV PROGRAMMES**



The Mauritius Revenue Authority (MRA) broadcasts a series of Radio and TV programmes aimed at educating the public about key taxation aspects and keeping them informed about the latest tax developments.

In December 2023, the MRA produced a number of programmes across various channels both in Mauritius and Rodrigues.

In Mauritius, the MRA made 3 TV interventions and 72 radio interventions to reach a wide audience. In addition, they aired 20 "one-minute radio programmes" on Kool FM and MBC Radio, ensuring that crucial tax information was disseminated effectively to the public.



#### **TAX ARREARS SETTLEMENT SCHEME (TASS)**

The Tax Arrears Settlement Scheme (TASS) which provides for full waiver of penalties and interests on tax arrears due, was renewed. If tax arrears, outstanding as at 02 June 2023, under an assessment raised or a return submitted on or before 02 June 2023 under the Income Tax Act, the VAT Act or the Gambling Regulatory Authority Act, are fully paid on or before 01 April 2024, any penalty and interest included in the tax arrears will be fully waived, provided that an application for the waiver is made to the MRA on or before 03 January 2024.

Taxpayers having assessments pending as at 02 June 2023 before the Assessment Review Committee, the Supreme Court or Judicial Committee of the Privy Council, and who wish to join the scheme, may do so by withdrawing the case before these institutions.


The scheme is **NOT** applicable to a person:

- i. Who has been convicted of an offence on or after 01 July 2012;
- ii. Against whom there are any pending or contemplated civil or criminal proceedings;
- iii. Who is the subject matter of an enquiry relating to drug trafficking under the Dangerous Drugs Act; arms trafficking, an offence related to terrorism under the Prevention of Terrorism Act; money laundering under the Financial Intelligence and Anti-Money Laundering Act; or a corruption offence under the Prevention of Corruption Act.

#### MRA COLLECTS RS. 137 BILLION: A 21.6% INCREASE



The Annual Press Conference of the Mauritius Revenue Authority (MRA) held on Thursday 31 August, 2023, at the MRA headquarters in Ehram Court, Port-Louis, was a success. Mr. Sudhamo Lal, the Director-General of MRA, highlighted the organization's achievements, new initiatives and projects.

MRA has reaffirmed its efficiency and effectiveness as a world-class revenue-raising authority, exceeding previous year's revenue collection by a growth of 21.6% for the fiscal year 2022/2023. In this period, MRA collected a total of Rs. 137 billion, a significant increase from Rs. 112.6 billion in 2021/2022. Out of the total collection, Rs. 128.2 billion was remitted to the consolidated fund, serving as a crucial resource for government financial activities that support public services, infrastructure development, social welfare programmes, and other national expenditures.

As for Corporate Tax, the latter has generated Rs. 22.6 billion, representing a substantial increase of 36.8% compared to the previous year's collections.

Net VAT collections for the fiscal year 2022-2023 amounted to Rs. 47,766 million, a growth of 24.8% over the previous financial year.

This annual gathering, attended by members of the MRA Management Team and media professionals, reiterated MRA's unwavering dedication to fostering innovation, transparency, and collaboration in its relentless pursuit of financial excellence and socioeconomic progress.

The event concluded on a high note with an engaging interactive session, allowing media professionals to actively participate and contribute their valuable insights.

### **MRA COLLECTS 1759 PINTS OF BLOOD**





On Wednesday 05, blood donors converged to three MRA locations in Port-Louis, namely MRA Head Office at Ehram Court, Custom House in Mer Rouge and Belfort Tower, Dauphine Street, where a total of 1184 pints of blood were collected.

On Friday 07, blood donors at the SSRN International Airport and its vicinity participated in this noble cause at ICCC, the Integrated Customs Clearance Centre at Le Chaland Road in Plaine Magnien. 575 pints of blood were collected there.

The MRA Blood Donation was officially launched by Dr. the Honourable Kailesh Kumar Singh Jagutpal, Minister of Health and Wellness, on Wednesday 05 July 2023 in the presence of Mr. Dhanraj Ramdin, Acting Director-General of MRA, members of the MRA Board, MRA Management Team members, Senior Officials from various Ministries, MRA personnel and blood donors.

The event witnessed a remarkable turnout, with employees and volunteers eagerly stepping forward to donate blood. Their selfless contributions will go a long way in helping patients in need of blood transfusions, including those battling life-threatening illnesses, undergoing surgery, or recovering from accidents.

Every year, MRA Blood Donation is also an opportunity for MRA to further contribute in the concept of Green Mauritius by distributing green plants to the donors. By now, MRA has embellished various corners of the Island of Mauritius by offering some 16 000 plants with





#### **E-INVOICING SYSTEM**



## ▶ **æ-INVOICING**



With the advent of this e-Invoicing system, providers of products and services will be required to fiscalise their invoices or receipts in real time with the MRA before issuing them to their customers.

In general, an economic operator makes use of an Accounting Package / Invoicing Solution / POS / ECR / ERP, also referred to as an Electronic Billing System (EBS), in order to invoice its customers for the sales made.

The benefits of the e-Invoicing system include:

• promotion of a level playing field;

- keeping up to date with the current worldwide evolution in taxation;
- fostering business transparency with external stakeholders;
- boosting technological readiness of economic operators to exchange invoices in real time and;
- promoting the image of Mauritius as a good place to do business as well as improving tax compliance.

# Financial Assistance Schemes: INDEPENDENCE ALLOWANCE





The Independence Allowance is a one-off allowance of Rs. 20,000 which is being paid by the Government of the Republic of Mauritius to eligible teenagers who attain the age of 18 years during the period 01 January 2023 to 30 June 2024.

To benefit from the allowance, the youth should be:

- i. a citizen of Mauritius;
- ii. a resident in Mauritius; and
- iii. has attained the age of 18 years during the period1 January 2023 to 30 June 2024

## **CSG CHILD ALLOWANCE OF RS 2,000**



A monthly CSG Child Allowance of Rs. 2,000 is being paid by the Government of the Republic of Mauritius, through the MRA, for the months of July 2023 to June 2024, to children aged up to three years.

#### Eligible child

To benefit from the allowance, the child should be:

- i. a citizen of Mauritius;
- ii. a resident in Mauritius; and
- iii. under the age of 3 years on the first day of the month in respect of which the allowance is payable.

#### **Eligible Parent**

Eligible parents refer to:

- i. the mother
- ii. the father, or
- iii. the person to whom a Court of competent jurisdiction has entrusted the guardianship of the child

Eligible parents are required to provide the bank details of the child held solely in his or her name or held jointly with one of his or her eligible parents. MRA will make payment of the allowance solely in that bank account.







### **HOUSING LOAN RELIEF SCHEME**



## Housing Loan Relief Scheme



Under the Housing Loan Relief scheme, a monthly allowance of 1,000 rupees is being paid by the Government of the Republic of Mauritius through MRA to an individual who has contracted a secured housing loan not exceeding 5 million rupees. This scheme took effect on 1st July 2023 and will last up to 30th June, 2024. Its objective is to provide relief to households affected by the rise in the cost of living.

The allowance is paid to an individual who:

- 1. Is a citizen of Mauritius;
- 2. Has contracted a secured housing loan from -
  - i. A bank or non-bank deposit-taking institution under the Banking Act;
  - ii. An insurance company under the Insurance Act;

- iii. The Sugar Industry Pension Fund;
- iv. The Development Bank of Mauritius; or
- v. the Statutory Bodies Family Protection Fund
- 3. Has, in Mauritius, purchased, constructed or extended the house for which the secured housing loan has been contracted; and
- 4. Has effected a repayment exceeding 1,000 rupees in respect of the secured housing loan in the month preceding the month for which the relief is payable.

#### **TV Programme:**

#### **GOOD GOVERNANCE**





Good governance is a fundamental principle that underpins the effective functioning and credibility of any organization, including the Mauritius Revenue Authority (MRA). This year, a TV programme focusing on good governance was aired on MBC TV. The aim was to educate the public on the significance of transparency, accountability, and ethical conduct in tax administration.

This television programme saw the participation of Mrs. Sumita Devi Mooroogen, Director, Internal Audit Division and Mr. Mamade Faisal Oozeerally, Director, Large Taxpayer Department at MRA.



## Capacity Building:

## **HARMONISED SYSTEM (HS)**





From October 3 to October 6, the Mauritius Revenue Authority (MRA) hosted a Regional Training of Trainers seminar on Harmonised System (HS).

Harmonised System (HS) is an internationally recognized classification system used for the uniform classification of goods traded across borders. HS provides a standardized framework for customs authorities to classify and identify products based on a set of codes and descriptions. This classification system also supports global trade, ensures precise categorization, and offers a uniform framework for classifying products.

The participants benefitted from the opportunity to expand their knowledge, enhance their professional skills, and establish useful networks with fellow experts in the field.



## **INDIVIDUAL INCOME TAX E-FILING SEASON 2023**



Individual Income Tax Returns e-Filing Season 2023



A total of **276,936** taxpayers fulfilled their civic duty for the Income Tax Filing Season 2023/24 by submitting their returns and paying the amount due to MRA. This year, three forms of assistance were provided for taxpayers filing their Individual Income Tax Returns:

- 1. e-Appointment: Taxpayers were given the opportunity to schedule a convenient time slot through MRA website on a specific day. MRA Officers then helped them in filing their income tax return through a WhatsApp Video Call at the appointed day and time.
- 2. MyRA: Individual taxpayers were provided

assistance with their inquiries by MyRA, a Virtual Assistant, and

**3. Helpdesk Unit:** Taxpayers had the option to call the MRA hotline, 207 6000, during working hours.

In addition to these means of assistance, explanatory videos were produced by MRA and uploaded on MRA website. Press releases were issued on a weekly basis, programmes were produced and broadcast on MBC TV, and both public and private radios. The content of the programmes were made available on MRA YouTube channel and social media platform.

#### **JOINT AGREEMENT**



#### 1. Double Taxation Avoidance Agreements (DTAAs) and Protocols

During the year 2023, various DTAAs and Protocols to DTAA have been negotiated by the international tax team at the Large Taxpayers Department of the MRA. DTAAs and Protocols have been concluded with Bangladesh, Jersey and Guyana. Procedures for the implementation of these Protocols and DTAAs have yet to be completed.

A DTAA negotiated with Hong Kong during the year 2022 has come into force in June 2023.



In view of upcoming negotiations, a virtual meeting was also held with Togo to discuss on the tax system of the two countries prior to scheduling negotiations.





## 2. MRA entered into four collaborative agreements with other local entities, this year. These Joint Agreements establish clear lines of communication, coordination, and information sharing between the MRA and other stakeholders.

## K-9 (SNIFFER DOGS)



The MRA's K9 Unit consists of 16 highly skilled dogs with an excellent sense of smell. They are deployed at the Port, Airport, Parcel Post, Courier Services and Container Terminal.

These Sniffer dogs are specifically trained to detect various items such as currency, hidden contraband,

drugs like cocaine, heroin, and methamphetamines, explosive materials, and illegal weapons. Their exceptional olfactory abilities enable them to identify even the smallest amounts of these substances, making them a crucial asset in the MRA's efforts to combat smuggling and illegal drug-related activities.

Each year, the MRA informs license holders, including those in Rodrigues, involved in selling alcohol, about the option to renew their licenses online at www.mra.mu

The Government of the Republic of Mauritius has

decided to postpone the Budget measure to increase the licence fees for the renewal of the above licences from 1 January 2024 to 1 January 2025. Consequently, the licence fees payable for the renewal of these licences for year 2024 remain unchanged and are as follows:

#### MENTORING PROGRAMME



On September 8, 2023, the Mauritius Revenue Authority (MRA) introduced a mentoring programme at the MRA Training Academy in Mer Rouge, under the chairmanship of Mr. Sudhamo Lal, the Director-General of MRA. All members of the MRA Management Team were present at the event.

121 mentees of various grades availed themselves of the services of a Mentor, for an initial period of 6 months. Through this tailor-made programme, 48 Mentors, consisting of Directors, Section Heads and Team Leaders, having expertise in their relevant fields have volunteered to share their experience with MRA staff.

The Mentoring Programme aimed to provide MRA staff with the opportunity to obtain guidance from a Mentor, on technical matters as well as behavioral competencies, to develop and progress in their careers.

#### **ONE-MINUTE RADIO PROGRAMME**



For the period January 2023 to December 2023, more than two hundred "One-minute radio programmes" were produced and broadcast on Kool FM and MBC Radio. The selected topics are based on the latest happenings at MRA. They include Financial Assistance Schemes, Value Added Tax, e-Filing, Customs Operations etc. The purpose of airing these programmes, conceived in a tersely manner and

broadcast in prime time, is to disseminate relevant information to the audience.

The same concept has been replicated in Rodrigues, where it was triggered in April 2023. From April to December 2023, MRA has produced and broadcast some 180 one-minute radio programmes in Rodrigues.

#### PORT SURVEILLANCE COMMAND CENTRE



The Prime Minister of the Republic of Mauritius, Hon. Pravind Kumar Jugnauth, inaugurated the Port Surveillance Command Centre at the Custom House on Monday 06 February, 2023, in the presence of Dr. the Honourable Renganaden Padayachy, Minister of Finance, Economic Planning and Development, the Chairperson and the Director-General of the MRA.

The Port Surveillance Command Centre, consists of three components, namely:

- A CCTV control room for live viewing of images from 201 cameras in the port area, focusing on freight stations, examination bases and port exits;
- A Scanning Room where live images from container scanners are received for final clearance by supervising officers; and,
- A control room for simultaneous monitoring of images through body-worn camera.

This SADC-funded project necessitated an investment of more than Rs. 20 million.









#### **QUALITY MANAGEMENT SYSTEM**





The MRA Quality Management System (QMS) refers to a set of policies, processes, procedures, and guidelines implemented by the Mauritius Revenue Authority (MRA) to ensure consistent delivery of high-quality services and effective management of its operations.

In 2010, MRA embarked on the implementation of a QMS aligned with the ISO 9001:2008 Quality Management Standard and was certified in 2012 by the Mauritius Standards Bureau (MSB).

QMS covers all Departments/Divisions and sites of the MRA. Some 250 processes for core functions and some 900 sub-processes are documented, which are used as Standard Operating Procedures (SOPs). These SOPs establish activities, responsibilities and records to be maintained and contribute greatly towards

good governance by enhancing transparency, accountability and efficiency of service.

In addition to improving the service level, the process and risk-based approach of QMS established a proactive culture of prevention and improvement. To review the performance of QMS and to bring changes therein, a yearly Management Review Meeting is held, chaired by the Director-General. A QMS team within the Internal Audit Division is responsible for the sustenance of QMS. It is responsible for conducting internal audits across the organization.

As external auditors, the MSB conducts yearly surveillance audits to assess the maintenance of the QMS. It also conducts a full audit of the system every 3 years to renew the ISO 9001:2015 certificate.

#### **REVENUE HOUSE**



MRA and the Côte D'Or Data Technology Park entered into an agreement on October 23, 2023, at the seat of MRA in Port-Louis. The aim of the agreement is to implement the Revenue House Project.

The Revenue House will be constructed in two phases at Côte d'Or Technopole. The first phase, of about  $13,100\,\text{m}^2$ , will cater for the current workforce of  $1,019\,\text{officers}$ . It will be eight levels high, (Ground +7).

The Phase I is expected to be completed by March 2027 at an estimated cost of Rs. 1.65B.

Phase II of the project, about 7,900 m², will start in July 2027. It will cater for future recruitments, training rooms with simultaneous interpretation systems, lecture theatres, conference room, mess room/cafeteria, fitness corner, etc



#### SHIP-IN-A-BOX SIMULATOR FACILITY







The United Nations Office on Drugs and Crime (UNODC) handed over a Ship-in-a-Box Simulator Facility to the Mauritius Revenue Authority (MRA) on Wednesday 15th of November, 2023.

The Ship-in-a-Box is made of stacked cargo containers with internal modifications to simulate the interior of a ship. It allows the training of Customs Officers and law enforcement agencies on the way ships should be searched.

The handing over ceremony took place at QUAY E in

Port-Louis in the presence of the Honourable Pravind Kumar Jugnauth, Prime Minister of the Republic of Mauritius, Dr. the Honourable Renganaden Padayachy, Minister of Finance, Economic Planning and Development, Mr. Sudhamo Lal, Director-General of the MRA, Mr. Tobin Bradley, Deputy Assistant Secretary for Africa and the Middle East, US State Dept. Bureau of International Narcotics and Law Enforcement Affairs, His Excellency Mr. Henry V. Jardine, US Ambassador to the Republic of Mauritius and Seychelles and other eminent personalities.

## **TAXPAYER SATISFACTION SURVEY (TSS) 2023**



The draw of the online Taxpayer Satisfaction Survey (TSS) 2023 was effected at the Head Office of the Mauritius Revenue Authority (MRA), Port-Louis, on Tuesday 31 October 2023. The first prize, a cash prize of Rs. 25,000, went to Mr. SHAH MUHAMMAD JALEEL KURREEMBUKUS. Mr. JAYECOOMAR DOOKY, won the second prize of Rs. 15,000, and Mr. DHINESH CAHOOLESSUR won the third prize of Rs. 10,000.

#### Salient results

- 35,919 taxpayers responded to this year's survey, which represents an increase of more than 80% as compared to last year.
- 93% of taxpayers surveyed are of the opinion that MRA administers the tax system fairly, and 98% say it has become easier to comply with their tax obligations. 82% of taxpayers assert that it is easy to report fraud and other illegal activities to MRA.

• The survey also revealed that 94% of the participants are of the opinion that the trust of taxpayers in MRA has improved, while 90% affirm that MRA is doing a lot to detect tax evasion.

To conclude, the outcome of the surveys conducted till date has allowed MRA to improve the quality of the services it offers to taxpayers', year-in, year-out.





### **UNDERCOVER AND SURVEILLANCE TECHNIQUES**

The training programme on 'Undercover and Surveillance Techniques' initiated by the Mauritius Revenue Authority (MRA) on 06 February 2023, was a success.

Undercover surveillance is essentially the process of investigating as discreetly and covertly as possible in order to determine the truth. Twenty-seven participants from the Indian Ocean Island States, namely, Madagascar, Comoros, Seychelles, the Mauritius Police Force (ADSU) and MRA Customs availed themselves of this training.

The participants benefited from a one-week intensive training dispensed by seasoned instructors from the US Department of Justice, Drug Enforcement Administration (DEA) based in the USA, Maputo, Mozambique, Dar es Salaam, Tanzania and Cape

Town, South Africa. The course included classroom instruction and practical exercises simulating a complex drug investigation across multiple locations

awareness campaign to connect with a diverse range of taxpayers, including individuals, small businesses, and larger corporations.

No doubt, the VAT awareness campaign plays a crucial role in promoting transparency and ensuring compliance with tax regulations. It facilitates precise calculation and reporting of VAT liabilities and also empowers the tax authority to identify any potential instances of tax evasion or fraudulent activities.



## WCO INTERNATIONAL CUSTOMS DAY



The Mauritius Revenue Authority (MRA) celebrated the International Customs Day (ICD) 2023 on Thursday 26 January 2023, under the theme: "Nurturing the next generation: promoting a culture of knowledgesharing and professional pride in Customs", put forward by the World Customs Organisation (WCO).

On that particular day, an automated system for the collection of Duties and Taxes was launched by Dr. the Honourable Renganaden Padayachy, Minister of Finance, Economic Planning and Development. It simplifies the actual process of goods bought in excess of normal duty-free allowance by passengers at MDFP and facilitates duty free shopping by incoming and outgoing passengers including tourists.



## X-RAY SCANNERS AT THE PORT AND AIRPORT 💥



X-ray scanners are an essential tool used by the Mauritius Revenue Authority (MRA) to enhance customs and border security. These scanners found at the Port and Airport play a vital role in detecting and identifying various prohibited or restricted items, such as drugs, weapons, contraband goods and undeclared goods.


MRA utilizes advanced X-ray scanning technology to provide detailed images of the contents of luggage,

cargo containers, and vehicles. These images are then carefully analyzed by trained customs officers to identify any potential threats or illegal items.

In conclusion, X-ray scanners are of utmost importance in drug seizure efforts at ports and airports in Mauritius. They enable authorities to detect concealed drugs, enhance security, facilitate efficient screening, conduct non-intrusive inspections, and act as a deterrent against drug smuggling.







#### YOUTH EDUCATIONAL TOUR



A half-day interactive educational tour was organized by the Mauritius Revenue Authority (MRA) for some one hundred Grade 11 to Grade 13 students of Loreto Convent College, Rose-Hill, at the Integrated Customs Clearance Centre (ICCC) at Le Chaland Road in Plaine Magnien, on Tuesday 09 May 2023. Through this endeavor, the students had the opportunity to interact with the MRA team, watch videos on the different aspects of taxation. It was followed by a guided tour through the recently inaugurated state-of-the-art building.

With an objective to instilling a tax culture based on voluntary compliance, MRA has since its inception

set up a dedicated department, namely, the Taxpayer Education and Communication Department (TECD) within its organisational structure. TECD aims to promote tax compliance through education. Its educational strategies are multi-scaled, comprising education sessions to large taxpayers, SMEs, the population at large, and more importantly, secondary school students who are prospective taxpayers, that is, taxpayers of tomorrow. As a matter of fact, it is more than necessary to convey the importance of paying taxes to them. The aim of the education strategy is to bring in the long run, a secular shift in the attitude from 'an obligation to pay' to 'a willingness to pay'.







# ZERO TOLERANCE TOWARDS BREACH OF INTEGRITY AND ETHICAL CONDUCT



The Mauritius Revenue Authority (MRA) has adopted a zero-tolerance approach towards breaches of its integrity policies and directives. Since its inception, the MRA Act has made provisions for two units to manage the integrity of its people and its system which are the Internal Affairs Division and the Internal Audit Division, respectively.

Furthermore, there is a Code of Conduct and Ethics (revised in 2014) which sets out the standard behavior of all Officers inside and outside the workplace. MRA has also a Disciplinary Code which highlights the different offences which may be committed by the Officers and the penalties applicable.

MRA has also implemented the following measures in 2023 to further enhance the integrity of its Staff:

#### i. Guidelines on Conflict of Interest

The Guidelines on Conflict of Interest applies to all officers of the MRA in the discharge of their respective duties and relate to the use of any power, authority or

discretion conferred under any of the Revenue Laws by such officers and any decision-making processes within the MRA as well as any other situation/ circumstance which may compromise the integrity of officers

#### ii. Guidelines on Social Media Policy


The Social Media Policy outlines protocols for using social media and provides guidance to employees during their personal use of social media or making public comments online.

#### iii. Prevention of Malpractice Manual (revised)

The Internal Affairs Division has published this manual of procedures on how it deals with allegations of malpractices and other complaints as well as processing and verifying declaration of assets. It also highlights how and what are the other duties performed by IAF such as Vigilance Exercises, Corruption Risk Mapping, and Surveys on Integrity.
